北京中安质环认证中心有限公司 (ZA-FCAV) 是 IATF 批准的指定的签约办公室, 针对区域办公室的设立, 依据 IATF 规则要求, 在 ZA-FCAV 签约办公室的参与下, 设立区域办公室, 这些区域办公室包括就影响 IATF 16949 认证活动的事宜从 ZA-FCAV 签约办公室获得权限和职责范围。区域办公室类型可包括 ZA-FCAV 的分公司或 ZA-FCAV 直接投资成立的子公司或者 ZA-FCAV 授权的其他类型的单位。

1 Regional Offices of Beijing Zhong An Zhi Huan Certification Center Co., Ltd

Beijing Zhong An Zhi Huan Certification Center Co., Ltd. (ZA-FCAV) is an IATF approved designated contracting office, for the establishment of regional offices, in accordance with the requirements of the IATF rules, with the participation of the ZA-FCAV contracting office, the establishment of regional offices, including the acquisition of authority and terms of reference from the ZA-FCAV contracting office on matters affecting IATF 16949 certification activities. The type of regional office may include a branch of ZA-FCAV or a subsidiary established by direct investment of ZA-FCAV or other types of units authorized by ZA-FCAV.

The ZA-FCAV Regional Office operates in accordance with regulations and certification accreditation specifications such as the Measures for the Administration of Certification Bodies (CNCA), the Control on Behalf of Entities Operating on Behalf of Certified Bodies for Accredited Management Systems (IAF MD 23), the IATF 16949 Automotive Certification Scheme Rules for Obtaining and Maintaining IATF Accreditation.

2.1 FUNCTIONAL ACTIVITIES OF FCAV AMERICAS CERTIFICACOES LTDA/FCAV AMERICAS CERTIFICATION S.R.L. (ZA-FCAV BRAZIL SUBSIDIARY).

The activities for which FCAV Americas is authorized to provide support to the headquarters include:

- 1) Contract approval;
- 2) Issuance of legally binding business agreements;
- 3) Customer management;
- 4) Management of dedicated auditors;
- 5) Training activities with auditors (such as experience sharing);
- 6) Supervision of auditors' performance (approval/rejection);
- 7) Planning of internal witnessing audits;
- 8) Certification decisions made by technical reviewers;
- 9) Creation of certificates;
- 10) Handling of appeals and complaints;
- 11) Entry into IATF database;
- 12) Implementation of internal audits;
- 13) Storage of customer audit files.
